#### The Policy Framework

The establishment of foreign universities in India has long been a subject of discussion. However, it became a reality with the implementation of the National Education Policy (NEP) 2020, which envisions the internationalisation of higher education by allowing the world's top 500 foreign universities— based on subject-wise global rankings or exceptional expertise in a specific field— to set up campuses in India.

Ministry of Education & Ministry of External Affairs, Govt. of India, 2025

In his inaugural address at the Akhil Bhartiya Shiksha Samagam in New Delhi, Prime Minister Shri Narendra Modi remarked, "The world is looking at India as a nursery of new possibilities... various global universities are also reaching out to us, expressing their interest in setting up campuses in India." This statement underscores the government's commitment to positioning India as a global hub for education and research excellence.

To facilitate this initiative, the University Grants Commission has framed the UGC (Setting Up and Operation of Campuses of Foreign Higher Educational Institutions in India) Regulations, 2023. A dedicated online portal— UGC FHEI (Foreign Higher Educational Institutions)— has also been launched to streamline applications and operational processes for foreign universities seeking to establish campuses in India.

Applications are reviewed by a Standing Committee, which makes recommendations based on the prescribed criteria. Upon approval, the UGC issues an in-principle sanction along with a Letter of Intent (LoI) to the applicant institution within 45 days.

In accordance with the regulations, the approved foreign university is required to establish its campus in India within two years from the date of the LoI, although the UGC may grant an extension on a case-by-case basis.

#### **Academic Programmes**

Under the regulations, foreign universities are permitted to offer a wide range of academic programmes including certificate, diploma, undergraduate, postgraduate, doctoral, and postdoctoral courses. These programmes must be delivered in person and cannot be offered through online, Open and Distance Learning (ODL), study centres, or franchise arrangements. However, up to 10% of the total lectures in a programme may be conducted in online mode to enhance flexibility and global exposure.



#### Faculty and Staff

Foreign universities operating in India enjoy full autonomy in the recruitment and selection of faculty and staff in accordance with their own institutional norms. They may independently determine qualifications, salary structures, and terms of service. However, the qualifications prescribed for faculty appointments must be equivalent to those required at the university's main campus in the country of origin, ensuring parity in academic standards and teaching quality.

#### Student Support and Assistance

These institutions may offer full or partial scholarships and fee concessions to students enrolled at their Indian campuses. Each university is required to establish an effective grievance redressal mechanism to address students' concerns promptly and transparently. In the event of discontinuation or disruption of a programme, or closure of a campus, the concerned foreign university must make suitable alternative arrangements to safeguard the interests of students— such as reallocating them to equivalent courses or programmes.

#### Award of Degrees

Upon successful completion of a programme, degrees shall be awarded under the name and seal of the foreign higher educational institution from its country of origin. The qualification conferred at the Indian campus will hold the same recognition and status as that awarded at the parent institution's main campus. Furthermore, such qualifications shall be considered equivalent to degrees granted by Indian higher educational institutions, without the need for any additional equivalence certification from any authority.

### Student Mobility and Credit Transfer

The regulations permit student mobility and credit transfer between the main campus of a foreign university and its Indian campus, as well as between Indian institutions and foreign universities. For example, an Indian student enrolled in a degree programme may complete one semester at the Indian campus of a foreign university and another at its main campus abroad, and vice versa. Similar exchanges are also permitted between Indian universities and foreign institutions, fostering greater academic flexibility and global exposure.

#### Institutional Collaboration

Foreign higher educational institutions may collaborate with existing Indian universities or companies in accordance with the provisions of the Foreign Exchange Management Act (FEMA) 1999 and the Foreign Contribution (Regulation) Act (FCRA) 2010. Such partnerships aim to promote knowledge exchange, research collaboration, and innovation in alignment with India's educational and economic development objectives.

#### India as a Global Knowledge Hub

The establishment of foreign university campuses in India marks a significant milestone in the nation's higher education landscape. This transformative reform is set to reshape the academic ecosystem by bringing world-class education within the reach of millions of aspiring and meritorious students who, until now, were unable to pursue studies abroad due to financial or logistical constraints. It provides an unprecedented opportunity for students to earn globally recognised degrees on Indian soil at a fraction of the cost, with substantial savings on travel, accommodation, and tuition expenses.

The presence of foreign universities will also catalyse the growth of high-quality research, publications, and academic infrastructure that meet global benchmarks. Access to international faculty, a broader spectrum of academic programmes and pedagogical approaches, and enhanced opportunities for collaboration and student mobility will enrich India's learning environment.

Collectively, these developments will strengthen India's position as a Global Knowledge Hub - a centre of academic excellence, innovation, and cross-cultural exchange that attracts scholars, researchers, and students from around the world.






